



ADVERTISEMENT OF TAX LIENS ON REAL PROPERTY FOR THE TAX YEAR 2018

Under and by virtue of the authority vested in the position of Tax Collector by Section 105-369 of the North Carolina General Statutes, and pursuant to an Order by the City of Hendersonville City Council, the City of Hendersonville Tax Collector is hereby advertising tax liens for the year 2018 upon the real property described below.

North Carolina General Statute 105-369 requires tax liens be advertised in the name of the owner as of the date of delinquency. The real property parcel subject to the lien, the name of the parcel's owner as of January 6, 2018 (and/or the names of subsequent owners), and the amount of taxes due are set out below. The amount advertised represents only the principal taxes for the tax year 2018 that were unpaid as of May 8, 2018. The actual amount owed by the taxpayer will be increased by all taxes owed for prior tax years and by all applicable interest, costs, and fees. The omission of prior years' taxes and interest, costs, and fees from the amount advertised will not constitute a waiver of the taxing unit's claim for these items. The City of Hendersonville Tax Collector recently mailed second notices to owners listed in this advertisement in an effort to promote payment of the taxes and prevent advertisement.

If these taxes as advertised remain unpaid, the tax collector will use all available collection remedies to collect the delinquent taxes, including the levy on personal property, the garnishment of wages, the attachment of bank accounts, rents, debts, or other property and the foreclosure and the sale of the real property. These collection procedures do not apply to taxpayers subject to pending federal bankruptcy petitions.

General Statute 105-348 states:

“All persons who have or who may acquire any interest in any real or personal property that may be or may become subject to a lien for taxes are hereby charged with notice that such property is or should be listed for taxation, that taxes are or may become a lien thereon, and that if taxes are not paid the proceedings allowed by law may be taken against such property. This notice shall be conclusively presumed, whether or not such persons have actual notice.”

Based on the above statutory language, it is the responsibility of the property owner, not the governing body, to determine if he/she owes taxes and to see that those taxes are paid. If you are currently in bankruptcy proceedings, please notify our office so we may adjust our records accordingly.
