 Chief Financial Officer's Computer was hacked on August 15th, 2019. After gaining
 access through her email, the hacker posed as one of our ACH Vendors (Diageo).
 Correspondence via email with CFO, the hacker gave account information/instructions to
 make all further ACH payments into this new account. Two (2) ACH payments were
 deposited into hackers account in the amounts of \$96,505.10 and \$104,715.59. After
 receiving notice from Diageo that the payments were not received, but money was gone,
 CFO realized we were hacked. CFO notified General Manager and Board Chairman of
 error. Board Chairman and General Manager notified Hendersonville City Manager.
 Hendersonville Police Department initiated investigation. Asheville Regional FBI Office
 has taken lead role in the investigation.
