

If less than three sealed bids are received at the time of bid opening, no bids will be opened.

The Project includes the following Work:

The City of Hendersonville 2026 Street Resurfacing & Bearcat Blvd Improvements project consists of asphalt milling and resurfacing along twelve (12) streets: 7th Avenue, Boxcar Street, Barker Street, Ashe Street, Beech Street, Cherry Street, Elm Street, East Pace Street, Jonas Street, Williams Street, 4th Avenue, and Bearcat Boulevard. The project includes the following major items of work:

- Milling of existing asphalt pavement
- Asphalt surface course, leveling course, and base course installation
- Removal and replacement of existing asphalt and concrete pavement
- Aggregate base course
- Concrete curb ramp removal and replacement
- 18-inch concrete curb and gutter
- Utility adjustments (catch basins, manholes, meter/valve boxes)
- Inductive loop sawcuts and lead-in cable installation
- Thermoplastic pavement markings and symbols
- Temporary traffic control

The project includes all related appurtenances necessary to complete the work.

The City reserves the right to waive any informality and to reject any and all proposals for any reason determined to be in the best interest of the City, except for the purpose of evading the bid laws. If awarded, the project will be awarded to the lowest responsive and responsible bidder taking into consideration quality, performance and the time specified in the proposals (if required to be specified). Non-responsive bids will be rejected.
