Chief's Monthly Summary

Let me first say, the mass murders in Buffalo and Uvalde absolutely sicken me. I pray we never see a crime on this scale in this community. I simply cannot comprehend a person's desire to commit mass murder against innocent people. We must find a way to prevent these types of events from continuing. While I do not have the ultimate solution, I offer my commitment that, with your help, we will do our very best to keep you safe from harm.

With respect to the killings in Uvalde, it appears, at least initially, that more could have been done during the response that may have saved lives. In the coming months and as the investigation unfolds, more will be learned that may help us improve our procedures. It will be our responsibility to study these findings and ensure that we strengthen our policies and training to avoid duplicating any shortcomings.

Saying that, we are being deliberate in enhancing our active shooter training. Such training will become part of our ongoing and continuous training program. Our officers will be better trained, better equipped, and more capable of stopping a crime like this from occurring in Hendersonville. Our goal is to respond and stop anyone intent on harming others, especially young defenseless children. Remember, you are also a vital link in helping prevent mass violence. Complaints and Findings

- 5/5/2022 An external complaint was received alleging an Officer's demeanor
 was inappropriate when talking to students. The investigation determined the
 Officer raised her voice only to be heard over the crowd of students. The
 complaint was therefore unfounded, and no action was taken.
- 5/5/2022 External complaint was received alleging an Officer was rude when speaking to a juvenile. The investigation determined the Officer was using a "scared straight" tactic at the request of the parents who were present during the encounter. The complaint was therefore unfounded, and no action was taken.

Vehicle Pursuits and Findings

Use of Reasonable Force (UORF) Incidents and Findings

- UORF 5/1/22: Officer pointed his firearm at a male who was believed to be armed. The male was walking back to his vehicle, where the gun was later found. The use of force was deemed reasonable and necessary. No action taken.
- UORF 5/4/22: Three officers pointed their firearms at a male after receiving a
 call that he was shooting the weapon in a backyard. Officers retrieved a BB gun
 the man had been firing that looked exactly like a real firearm. The use of force
 was deemed reasonable and necessary given the circumstances. No action
 taken.
 - ➤ We treat the pointing of a firearm by an officer to be a use of force. In both cases, the officer(s) showed considerable restraint and discipline in recognizing the incident as dangerous, but not deadly, for the officers and the public.
- UORF 5/19/22: Officers arrested a male for trespassing from Ingles. Officers used soft hand techniques to subdue the male when taking him into custody. The use of force was deemed reasonable and necessary. No action taken.
- UORF 5/28/22: Officers stopped a vehicle for a revoked license. A male passenger ran from the vehicle and was tased by Officers. The male had outstanding warrants and drugs on his person. Use of force was deemed reasonable and necessary. No action taken.

Operations/Notable Events

• 5/11/22 – A stolen property investigation at a home resulted in the seizure of a mobile meth lab. The suspect, who did not live at the residence, was wanted in

Mecklenburg County on 55 outstanding warrants. Methamphetamine, a firearm, and several stolen items were recovered. The suspect is currently in the Henderson County Jail on a \$200K secured bond. He was charged with several crimes including possession of a firearm by a felon.

• 5/27/22 – Detectives assisted Special Agents from the US Department of Homeland Security in arresting a Virginia man for interstate child sex crimes. Male was arrested without incident.

Budget Summary

- We are approximately 92% through the fiscal year.
- \$826,282.00, or 93.8% of the FY 21/22 operating budget has been encumbered to date.
- FY 22/23 budget items were approved by City Council on June 2, 2022.

Community Outreach/Special Events

- 5/13/2022 Rooftop Cops: Officers and staff conducted a fundraising event at Chick-fil-A on Four Seasons for Special Olympics of Henderson County. A total of \$3200 was collected.
- 5/22/2022 City's 175th Anniversary Officers and staff met with citizens, answered questions, gave tours of our vehicles, and provided bottled water, coffee mugs, and stress relief toys. The department's badge commemorating Hendersonville's 175th anniversary was unveiled, and Officers will be wearing the badges for the remainder of 2022.

Awards and Recognitions

- Detective LaRowe and Officer Nix received their Intermediate Law Enforcement Certificates. This is the second highest certificate an Officer can receive in North Carolina. It is only achievable through years of service, formal education, and completion of training hours.
- Officer Baird was recognized as the Quarterly Service Excellence recipient for the City of Hendersonville. Ofc. Baird gave a handicapped man a ride home when his electric wheelchair ran out of battery life. Two other city employees were also recognized for carrying his wheelchair to his house and helping him recharge it.
- Monica Howard received the Positive Influence Award from NC National Emergency Number Association for her work with mental health for telecommunicators in North Carolina.
