

Boil Water Advisory

Restaurants, School Lunchrooms, Food Stands, Commissaries, Catered Elderly Nutrition Sites, Mobile Food Units, Push Carts, Discontinue consumption of tap water. Turn off icemakers, soft drink and water fountains. Label water sources "Do Not Drink". Provide bottled water or drinks. Recommend use of single service items only. Do not use fresh vegetables that would have to be washed. Serve fruit with peels (e.g. bananas, oranges) and use pre-washed, frozen or canned vegetables. Use only bagged ice from an approved source. Boil any water that is to be used for washing utensils. Use hand sanitizers after hand washing.

Motels, Bed and Breakfast Homes, Bed and Breakfast Inns, and Summer Camps: All meals or food service provided should be purchased or catered in from an approved source. Discontinue consumption of tap water. Recommend that tap water not be used for bathing purposes since inadvertent consumption may take place. Turn off icemakers, soft drink and water fountains. Label water sources "Do Not Drink". Provide bottled water or drinks, or treat water used for drinking or washing food by either boiling or adding chlorine to disinfect the water. Use only bagged ice from an approved source. Discontinue water play with the exception of pools operating under health department permit. Use hand sanitizers after hand washing.

Schools, childcare facilities, residential care facilities and adult day service facilities: All meals or food service provided should be purchased or catered in from an approved source. Discontinue consumption of tap water. Recommend that tap water not be used for bathing purposes since inadvertent consumption may take place. Turn off icemakers, soft drink and water fountains. Label water sources "Do Not Drink". Provide bottled water or drinks, or treat water used for drinking or washing food by either boiling or adding chlorine to disinfect the water. Use only bagged ice from an approved source. Discontinue water play with the exception of pools operating under health department permit. Use hand sanitizers after hand washing. Rinse tooth brushes with water from an approved source or a properly disinfected supply. Use hand sanitizers after hand washing.

Hospitals, nursing homes, rest homes and other institutions:

Discontinue consumption of tap water. Turn off icemakers, soft drink and water fountains. Label water sources "Do Not Drink". Provide bottled water or drinks, or treat water used for drinking or washing food by either boiling or adding chlorine to disinfect the water. Use hot water sanitizing for eating and drinking utensils or use only single-service utensils. Serve only food heated to 165° F as part of the cooking process, packaged foods, and fruit, which is normally peeled before eating. Use hand sanitizers after hand washing. Notify the licensing agency that the water supply may be unsafe. Rinse tooth brushes with water from an approved source or a properly disinfected supply. Use hand sanitizers after hand washing.

Public swimming pools:

Turn off water fountains and label water sources "Do Not Drink".

Tattoo Establishments:

Use bottled water for rinsing needles and cleaning tattooed skin. Discontinue consumption of tap water. Turn off water fountains and label water sources "Do Not Drink". Use hand sanitizers after hand washing.
